A Summary of Actions by the Board of Trustees

Regular Meeting of December 12, 2005

The Board of Trustees met on Monday, December 12, 2005 at 7:00 p.m. for the purpose holding a regular meeting. Members present were: President, John R. Williams; Vice-President, Karen Thornton; Howard Kessinger; Roxanna Maddox; Clinton Farris; and Superintendent, Dennis Bennett.

Action Items:

- A motion by Howard Kessinger was made to approve Tab Sims and Steven Thompson as the new Jack County Appraisal District board members, representing JISD.
- The Board voted to approve the consent agenda items.

Information Items:

- John R. Williams recognized Nelson Oliver and thanked him on behalf of the Jacksboro ISD for his fourteen years of service to the district as a Jack County Appraisal District board member, representing JISD. A plaque was presented to him from JISD for his service to the district.
- Ellenda Boykin was presented a plaque for her twenty-eight years of service to JISD. She served as the school nurse from 1957-1985 and on behalf of JISD, John R. Williams thanked Ellenda Boykin for her commitment and service to the district.
- Rhonda Hicks thanked the Jacksboro ISD trustees for their support and assistance to her while she was a paraprofessional at JISD and continuing her educational requirements to become certified as a special education teacher. Mrs. Hicks presented the board with a certificate thanking them for their support.
- Principals' Reports:
High School principal, Brad Burnett, reported enrollment at 271 for High School and 8 students at the Learning Center. He reported the High School activities planned for December. He also reported on FCA, volleyball, football, boys and girls basketball and baseball in athletics; the Christmas Concert in Band; and FFA events and awards.

Mr. Monkres reported 227 students enrolled at middle school. He also reported on student activities; upcoming events; the State LDE Contest in Huntsville; and 2nd Six Weeks Honor Roll.

Mrs. Zeitler reported Elementary enrollment at 468. She also reported on the UIL contestants and winners; activities; field trips; and upcoming events scheduled at the Elementary.

- Superintendent's Report:

Mr. Bennett stated that the 2006 Bluebird bus has been ordered with an expected delivery date of July, 2006. It is a 59 passenger bus.
