Call to Order:

The meeting was called to order at 7:01 p.m. by Board President Brent Hackley, with a quorum being present. Ken Swan led the prayer and pledge.

Administration Reports:

A. Superintendent

Dwain Milam provided the Superintendent's Report. Those matters included the following:

- IV. Mr. Milam presented the Energy Management Report which are currently running ahead of schedule according to the amount of savings that was forecasted when purchased. Guidelines for Summer school classrooms to be utilized were recommended and followed.
- V. Christy Thomas presented the preliminary budget for 2018-19 by function. Budget was conservative in pupil projections.
